Prior to the Effective Date, the 15,721,411 Shares were registered in the name of DBS Vickers Securities (Singapore) Pte Ltd.

On the Effective Date, all the ordinary shares of par value of US\$1.60 each of the Company ("Shares") ("Scheme Shares") were transferred from the shareholders of the Company ("Shareholders") holding Shares as at the books closure date for determining the entitlements of the Shareholders in respect of the Scheme ("Scheme Shareholders") to Uni-Asia Group Limited ("NewCo").

In consideration of the transfer of the Scheme Shares, NewCo had on 26 May 2017 allotted and issued one new ordinary share ("NewCo Share") for every one Scheme Share transferred by the Scheme Shareholders.

Following the allotment and issue of one NewCo Share for every one Scheme Share transferred by Yamasa Co., Ltd, Yamasa Co., Ltd holds more than 20% of the votes attached to voting shares of NewCo. Accordingly, Yamasa Co., Ltd is technically deemed to be interested in the Shares transferred to NewCo by virtue of Section 4 of the Securities and Futures Act, Chapter 289 of Singapore.

Please refer to the Company's announcement dated 29 May 2017 for further details on the Scheme, including the expected date of debiting of Shares from the securities accounts of depositors and the expected date for the crediting of NewCo Shares into the securities accounts of depositors pursuant to the Scheme.
